Periodontal Disease and Diabetes: Update and Interprofessional Management





Wenche Sylling Borgnakke ("Venke") is a Senior Research Associate in Health Sciences at University of Michigan School of Dentistry. She earned DDS and PhD degrees in Copenhagen and a Master of Dental Public Health degree in Michigan. Dr. Borgnakke has lectured nationally and internationally, and she is a member of CDC/AAP Workgroup on Periodontitis Surveillance. AAP awarded her a 2012 Special Merit award and the 2013 and 2016 Clinical Research Awards for articles in the Journal of Dental Research and Journal of Periodontology. She has published about 80 papers and 10 book chapters, the two most recent being "The Traveling Oral Microbiome" in a book on oral-systemic health and "Oral Health and Diabetes" in the Federal US mammoth work called "Diabetes in America."

Mark Cucuzzella is a Professor in the Department of Family Medicine, West Virginia University and the Director of Pre-Doctoral Family Medicine Education. He earned his MD from University of Virginia, and completed his internship and residency at David Grant Medical Center, Travis Air Force Base, California. He leads the Rural Family Medicine Residency Program of West Virginia University. In this role, Dr. Cucuzzella participates in a full spectrum of family medicine with a focus on inpatient care, supervises and teaches residents and students in all care settings and directs the pre doctoral program for third year medical students. Dr. Cucuzzella is a retired LTC from the US Air Force, where he was the lead in physical fitness program development.



Dr. Ira B. Lamster received his D.D.S. from the State University of New York at Stony Brook (1977), his M.M.Sc. from Harvard University (1980) and a Certificate of Special Training in Periodontology from the Harvard School of Dental Medicine (1980). Dr. Lamster served as Dean of the Columbia University College of Dental Medicine from 2001 to 2012, and Senior Vice President of Columbia University Medical Center from 2006 to 2012. From 2012 until 2017 he was in the Department of Health Policy & Management of the Columbia University Mailman School of Public Health. He is currently Dean Emeritus and Professor of Dental Medicine at Columbia, and Clinical Professor at the Stony Brook University School of Dental Medicine. Dr. Lamster's research efforts have focused on diagnostic testing and risk assessment for periodontal disease, the interrelationship of periodontal disease and systemic disease, the oral health care needs of older adults and the future of dental education and practice. Dr. Lamster is the author of more than 200 manuscripts and book chapters. He is the editor of "Improving Oral Health for the Elderly," (2008), both the January 2011 and October 2012 issues of the Dental Clinics of North America (addressing "Contemporary Concepts in the Diagnosis of Oral Dental Disease", and "Primary Health Care Activities in the Dental Office", respectively). He also the editor of "Diabetes Mellitus and Oral Health: An Interprofessional Approach" (2104)2014, and the October 2016 issue of Periodontology 2000 ("Geriatric Periodontology"). He currently serves as Editor-in-Chief of the International Dental Journal.

COURSE DESCRIPTION

West Virginia has one of the highest rates of diabetes in the US. Management of diabetes involves addressing multiple factors which impact control of diabetes, which includes improving nutrition, incorporating exercise into daily activity, and eliminating smoking. Over the past 25 years, a substantial body of evidence has been collected demonstrating the strong association of poor oral health, specifically periodontal disease, with the clinical development of diabetes and its effects on the ability for a patient with diabetes to manage the disease. This symposium will provide the participant an update on the association of periodontal disease with diabetes. The speakers will also expand upon the medical management of diabetes and the impact improved oral health can have on this management. Finally, this program will emphasize the need for intensive interprofessional management of these patients, requiring dental and medical health professionals to work closely and cooperatively in order to achieve the best clinical outcomes for these patients.
