Antonio Palladino, MD 1927-1991

A native of Italy, Dr. Antonio Palladino received his medical degree with highest honors from the University of Naples, Italy, and served his residency in Obstetrics and Gynecology at Baltimore City Hospital, University of Maryland Division.

As a faculty member in the Department of Obstetrics and Gynecology at West Virginia University from 1964-1974, Dr. Palladino served as vice-chairman and director of the student teaching program. He later served as a clinical professor and was on the staff at Monongalia General Hospital. From 1974 until his death in June 1991, Dr. Palladino practiced with Drs. Walter A. Bonney and Kamal M. Behnam in Morgantown. He was certified by the American Board of Obstetrics and Gynecology and the Italian Board of Obstetrics and Gynecology.

In December 1991, Mrs. Adriana Palladino established the Antonio Palladino Lectureship in Obstetrics and Gynecology. Mrs. Palladino, who trained in Italy as a pharmacist, was a volunteer at Ruby Memorial Hospital. She was a researcher in the Department of Pharmacology and Toxicology at the WVU Health Sciences Center from 1966-1970.

Philip Samuels, MD, is director of the Maternal Fetal Medicine Fellowship Program and director of the Obstetrics and Gynecology Residency Program. He is a professor of obstetrics and gynecology in the Division of Maternal Fetal Medicine at The Ohio State University Wexner Medical Center

Originally from Corsicana, Texas, Dr. Samuels earned his medical degree from Texas Tech University School of Medicine, Lubbock, Texas. He completed his residency at Eastern Virginia Graduate School of Medicine, Norfolk, Va., followed by a fellowship at the Hospital of the University of Pennsylvania.

Dr. Samuels' clinical and research interests include the medical complications of pregnancy, especially neurological, hematological, renal, autoimmune and gastrointestinal (including liver). He as written book chapters and papers in these and other areas.

He is passionate about educating students, residents and fellows. He enjoys preparing them for lifelong learning; and teaching and modeling professionalism. His favorite part of medical education is bedside teaching.

Outside of medicine, Dr. Samuels enjoys spending time with family, gardening with native Ohio plants, bird watching, photography, theater and classical music.

Thrombophilias and the obstetrician: fact, anecdote, and logical management

During pregnancy, a woman's physiology changes is such way that she is at higher risk for venous thromboembolic events. Furthermore, women who are unfortunate enough to have inherited and/or acquired thrombophilia's are even at higher risk. This thrombophilias can place the woman at increased risk for preeclampsia, fetal growth restriction, stillbirth, placental abruption, and recurrent miscarriage. The best management for these patients is poorly understood, this often leads to under- as well as over management. Dr. Samuels is a Maternal-Fetal Medicine Specialist who is nationally and internationally known for his expertise in these matter. His talk will provide the audience with a rational approach to these patients.




