Course Description

The 33rd Annual West Virginia Addiction Training Institute (ATI) features current developments within the physical, emotional, social, and spiritual areas of substance use disorder (SUD) behavior and treatment. Special topics for 2022 include: Identity and Health in SUD recovery; Motivational Interviewing; LGBTQ and SUD; Vocational Rehabilitation; Impact of SUD on the Developing Child; Veterans; Pregnancy and Post-Partum Treatment; Ethics; DEI Issues; Gambling Addiction; Peer Recovery Coaches in Clinical Settings; and Cannabis. This course is designed for new and experienced professionals who seek a thorough review of both the established fundamentals of addiction treatment and current approaches to working with the behavioral addictions and the substance use disorder population. The training is valuable for those working or planning to work in the areas of mental health, addictions counseling, courts and corrections, school counseling, nursing, and psychology.

Course Objectives

The goals of the ATI are to 1) assist professionals in examining the increasing issues related to addiction in the state; 2) provide an up-to-date look at treatment strategies; and 3) disseminate effective therapeutic techniques in working with individuals, family, and community members affected by addiction.

Following this course, participants should be able to:

- Name three factors that have disproportionately affected racial and ethnic minorities with substance use disorder.
- Explain how Compassion Fatigue impacts quality patient care
- Identify the 4 components of the Spirit of Motivational Interviewing
- Describe the epidemiology of and clinical characteristics associated with disorder gambling.
- Describe the radical shift in identity that promotes recovery
- Identify cultural factors that may impact continued substance use and mental health treatment in veterans
- Describe the impact of SUD on the developing brain.
- Describe the effect of THC on the developing brain
- Describe components of evidence-based psychosocial interventions for pregnant and post-partum women with substance use disorder.
- Identify elements of an LGBTQ+ responsive SUD treatment setting.
- Identify barriers and facilitators to effective peer recover support services.
