# **Certified Tobacco Treatment Training Program**

Certified Tobacco Treatment Specialists (CTTS) are trained to target an individual's nicotine addiction level and provide effective, evidence-based interventions using pharmacotherapy and counseling.

**Release Date:** July1, 2025 – May 22, 2026. The tobacco treatment specialist content is delivered as a self-paced, online learning course through WVU's E-Campus system.

# **Target Audience:**

This course is recommended for addiction treatment professionals, licensed professional counselors, dentists, dental hygienists, educators, nurse practitioners, nurses, pharmacists, physicians, physician assistants, respiratory therapists, social workers and others who encounter tobacco using patients/clients/students. Must have a **minimum of an associate degree to participate**. To receive a tobacco treatment specialist certificate, one must complete the entire online training which includes 15 self-test examinations, attain a minimum score of 80% on the tobacco treatment specialist certification examination and proclaim a tobacco-free lifestyle.

# Learning Objectives: Following the course, participants should be able to:

- Tobacco Dependence Knowledge and Education: State clear and accurate information about tobacco use, strategies for quitting, the scope of the health impact on the population, the causes and consequences of tobacco use.
- Counseling Skills: Demonstrate effective application of counseling theories and strategies to establish a collaborative relationship, and to facilitate client involvement in treatment and commitment to change.
- Assessment Interview: Conduct an assessment interview to obtain comprehensive and accurate data needed for treatment planning.
- Treatment Planning: Demonstrate the ability to develop an individualized treatment plan using evidence-based treatment strategy.
- **Pharmacotherapy:** State clear and accurate information about available pharmacotherapy options and their therapeutic use.

- **Relapse Prevention:** Offer methods to reduce relapse and discuss ongoing support for persons with tobacco dependence.
- **Diversity and Specific Health Issues:** Demonstrate competence in working with population subgroups and those who have specific health issues.
- **Documentation and Evaluation:** Describe and use methods for tracking individual progress, record keeping, program documentation, outcome measurement and reporting.
- Professional Resources: Utilize resources available for client support, professional education or consultation.
- Law and Ethics: Consistently use a code of ethics and adhere to government regulations specific to the health care or worksite setting.
- **Professional Development:** Assume responsibility for continued professional development and contribute to the development of others.
